

2024/2025 Precept

The precept calculation for 2024 – 2025 is shown below.

WDC has confirmed that the 2024/25 Council Tax base for Pevensey parish will be 1346.4 properties, a decrease of 7.4 properties on the 2023/24 tax base.

The Council Tax base is the statutory calculation of the number of ‘chargeable’ households for each parish of the district and is used by WDC, as the Council Tax billing authority, to calculate the Council Tax in each area.

The parish Council Tax is calculated by dividing the council precept by the Council Tax base figure. This provides the band D Council Tax figure.

The 2024/25 council precept figure of £149,535 is therefore divided by the 2024/25 tax base figure of 1346.4 to calculate the band D parish Council Tax of £111.06 per year.

This represents an increase of 5.6% on the 2024/25 council precept figure, which amounts to an increase of £5.86 per year, £0.49p a month or £0.11p per week per band D household.

The parish councils is required to hold between 3 - 12 months of net revenue expenditure in its general reserves to prepare the council financially for the future and also covers the depreciation of its assets.

The band D charge is calculated as the precept is divided by the tax base (the number of band D equivalent dwellings in the parish).

- Tax base in 2022/2023 was 1350.9, precept was £136,231 so band D charge is $\text{£}136,231/1350.9 = \text{£}100.84$
- Tax base in 2023/2024 was 1354.0, precept was £142,441, so band D charge is $\text{£}142,440/1354.0 = \text{£}105.20$

So, for a band D property, the parish council precept increase paid by the council taxpayer for 2024/2025 will be £111.06.

Therefore, the proposed budget for 2024/25 represents an increase in the parish council's element of precept of £5.86 per year per band D household which equates to just over £0.11p per week or 5.6%

The total increase for the overall parish council budget for 2024/2025 is £28,682.50.

To cover the budget increases and the financial pressures the parish council are faced with, £7,094 will be covered by the precept. The remaining balance will be covered by the reallocation and saving from the parish councils existing funds.
